The New York College of Health Professions conducts ongoing review of the institution and the programs, and the outcome measures outlined in this report are inclusive of all measures of institutional effectiveness. The College uses this information introspectively to review program outcomes with regard to retention rate, graduation rate, licensure examination pass rate, licensure rate, and job placement rate.

Students enroll at New York College of Health Professions to become licensed professionals in the fields of massage therapy, acupuncture, and Chinese herbology.

To compile the data found in this report, the College conducted alumni surveys, gathered board results from both the National Certification Commission for Acupuncture and Oriental Medicine (NCCAOM) and the New York State Education Department (NYSED), and analyzed enrollment reports.

This report is comprehensive in its breadth of information and is accurate at the time of publication. Some data may change over time as alumni seek additional licensure, either in New York or in other states.

Enrollment at the College has been greatly impacted by the COVID-19 Pandemic since Spring 2020 trimester. The ongoing institutional and programmatic accreditation issues have also impacted the College greatly.

The College aims to provide its stakeholders with an opportunity to review relevant information as it pertains to the quality of education at the College.


1st year Retention Rate

The total retention of massage therapy students is combined 53.23%. The national average for private 2-year institutions is 60.2%. The drastic drop of retention rate beginning Spring 2021 is the result of NYCHP's Institutional Accreditation issues compounded by COVID-19 pandemic.





Graduation Rate


The graduation rate is a measurement of the number of students who completed the program within the allowed timeframe.

Therefore, for the three years of reported data, we will be using the statistics on graduation from Summer 2017 to Spring 2020. (Students enrolled in Spring 2020 had three years, until Fall 2022, to graduate.)

The graduate rate for the School of Massage Therapy for the three-year period is 45.70%




Acupuncture

The graduation rate for Graduate School of Oriental Medicine – Acupuncture program is 20.46%.




Oriental Medicine

The graduation rate for Graduate School of Oriental Medicine – Oriental Medicine program is 21.04%.




Board Examination Pass Rate



Note that the NCCAOM examinations required for licensure in New York State are the Acupuncture with Point Location (APL) and Foundations of Oriental Medicine (FOM). To receive NCCAOM's Diplomat status, graduates would need to also pass the Biomedicine (BIO) examination. There are several states which require students to also pass the Chinese Herbology (CH) examination to be licensed to legally practice acupuncture. New York State does not require BIO and CH as part of their licensure requirement, therefore students that take BIO and CH are typically pursuing licensure in other states, or NCCAOM's Diplomat status.

The graduates in the past two years have been doing better on FOM exam than the APL exam. In 2021, APL, BIO, and CH have increased rate than the previous year. As the Comprehensive Exit Exams (graduation exams) has been modified to fit NCCAOM standards, the GSOM department expects the NCCAOM passing rate to increase.


Licensure Rate

The average licensure rate since 2016 is 75.47% and average out of state licensure rate since 2016 is 9.16%.



Licensure Status - GSOM



The average licensure rate since 2016 is 72.30%, average out of state licensure rate since 2016 is 6.20%, average NCCAOM certification rate is 9.57%.

For students in the Acupuncture and Oriental Medicine Program, the licensing requirements differ from state to state. Therefore, the licensure examination pass rate is not directly proportional to the licensure rate.


Job Placement Rate

Job Placement Rate




The average job placement rate since 2016 is 53.19%.

Job Placement Rate - GSOM



The average job placement rate since 2016 is 64.35%.

Since the job placement rate was calculated by the alumni who confirmed they were working in the field, divided by the number of graduates reported by the registrar, this method is inaccurate as the rate includes the alumni who did not respond. The actual job placement rate is likely to be significantly higher. However, the current data gives us the minimum value, i.e., the actual rate will not be lower than the collected data.

In the future, the College will discuss calculating the rate based on the total number of respondents to the survey, Also the College will continue to develop methods to obtain more accurate data, as well as increasing the job placement rates.
